ORDERED that Claim No. 11495 (Commercial Net Lease Realty, Inc.) is reinstated as an administrative expense claim in the amount of \$13,217.89<sup>3</sup>; and it is further

ORDERED that Claim No. 10491 (Judith Sacks) is reinstated and allowed as an unsecured nonpriority claim in the amount of \$2,455.56<sup>4</sup>; and it is further

ORDERED that the signed Stipulation between the Debtors and Two Park Center, LLC attached hereto is approved and entered as if it had been executed individually by this Court; and it is further

ORDERED that the Debtors reserve their rights to object to any Claim listed on any Exhibit to this order for any reason.
