**FIRST CONTINUATION ORDER GRANTING THE RELIEF SOUGHT IN
DEBTORS' SECOND OMNIBUS OBJECTION TO CLAIMS**

Upon the Debtors'² Second Omnibus Objection, seeking entry of an order disallowing, or reclassifying and/or reducing and allowing, as appropriate, certain Claims; and no previous application having been made; and upon consideration of the Second Omnibus Objection and all responses thereto; and due and proper notice of the Second Omnibus Objection having been given, it is hereby

ORDERED that the Objection listed on Exhibit A to this Order is allowed in the amount and with the priority indicated thereon; and it is further

ORDERED that each of the Claims listed on Exhibit B to this Order is withdrawn without prejudice to the Debtors' right to object in the future to such Claims on any grounds; and it is further

ORDERED that each of the Claims listed on Exhibit C to this Order is expunged and disallowed for all purposes; and it is further

ORDERED that each of the Reclassify Claims, the Reduce and Allow Claims and the Reclassify, Reduce and Allow Claims listed on Exhibit D is allowed in the amount and with the priority indicated thereon; and it is further

ORDERED that Claim No. 453 (Integral, Inc.) is reinstated as an unsecured nonpriority claim in the amount of \$967,565.63³; and it is further

ORDERED that Claim No. 1733 (Bruyette, Lance) is reclassified and allowed as a priority claim in the amount of \$166.25 and an unsecured nonpriority claim in the amount of \$433.50⁴; and it is further

ORDERED that Claim No. 940 (Commonwealth of Pa. Dept. of Revenue) is reduced to \$14,921.88 as a priority claim, but is not allowed at this time; and it is further

ORDERED that Claim No. 1733 (Hinz, Michael and Vicki) is reinstated and allowed as a priority claim in the amount of \$1,665.96⁵; and it is further

ORDERED that Claim No. 9090 (Noyes, Heidi) is reclassified and allowed as a priority claim in the amount of \$2,100.00 and an unsecured non-priority claim in the amount of \$725.49⁶; and it is further

ORDERED that Claim No. 8108 (Lewis, Sharie) is allowed as a priority claim in the amount of \$2,138.94, the court having denied the objection on August 15, 2002; and it is further

ORDERED that the signed Stipulation between the Debtors and Two Park Center LLC attached hereto is approved and entered as if it had been executed individually by this Court; and it is further

ORDERED that the Debtors reserve their rights to object to any Claim listed on any Exhibit to this order for any reason.
