**ORDER GRANTING THE RELIEF SOUGHT IN

ORDERED that each objection listed on Exhibit B to this Order is withdrawn without prejudice to the right of the Debtors to object in the future to such Claims on any grounds; and it is further

ORDERED that the Claim listed on Exhibit D to this Order (Claim No. 17, Wickens Express d/b/a John Wicken) is reclassified and allowed as an unsecured non-priority claim in the amount of \$9,500.00; and it is further

ORDERED that the Debtors reserve their rights to object to any claim listed on any exhibit to this order for any reason.
