Franklin Avenue, El Segundo, CA 90245, Attn: HomeLife Corporation. If such claim is not timely filed and served, such claim shall be forever barred.

The Debtors consist of the following entities: HomeLife Corporation, HL Holding Corporation, HomeLife de Puerto Rico, Inc., Furniture Holdings, LLC and HLC 1 LLC. HomeLife de Puerto Rice and HL Holding Corporation are not part of the Plan.
