**NOTICE OF ENTRY OF CONFIRMATION ORDER
AND EFFECTIVE DATE**

TO CREDITORS, EQUITY INTEREST HOLDERS AND OTHER PARTIES IN INTEREST
OF THE ABOVE-CAPTIONED DEBTORS:

PLEASE TAKE NOTICE that on March 6, 2003 the United States Bankruptcy Court for the District of Delaware entered an order confirming the Joint Liquidating Plan of Reorganization Under Chapter 11 of the Bankruptcy Code, dated January 16, 2003 (the "Plan"), filed by the above-captioned debtors (the "Debtors").²

PLEASE TAKE FURTHER NOTICE that the Effective Date of the Plan was designated by the Liquidating Debtors as six months from the date of the entry of an order confirming the Plan (the "Confirmation Date").

PLEASE TAKE FURTHER NOTICE that the Distribution Record Date shall be thirty days prior to the Effective Date.

PLEASE TAKE FURTHER NOTICE that all stock interests in the Liquidating Debtors shall be cancelled.

PLEASE TAKE FURTHER NOTICE that no later than thirty (30) days after the Confirmation Date, Claims arising out of the rejection of executory contracts or unexpired leases (except those leases included in the Settlement and Compromise Agreement) must be filed with the Bankruptcy Management Corporation, 1330 E. Franklin Avenue, El Segundo, CA 90245, Attn: HomeLife Corporation. If such claim is not timely filed and served, such claim shall be forever barred.

¹ The Debtors consist of the following entities: HomeLife Corporation, HL Holding Corporation, HomeLife de Puerto Rico, Inc., Furniture Holdings, LLC and HLC 1 LLC. HomeLife de Puerto Rico and HL Holding Corporation are not part of the Plan.

² Capitalized terms not defined herein shall have those meanings ascribed thereto in the Plan.

PLEASE TAKE FURTHER NOTICE that all final applications by professionals for compensation or reimbursement of expenses pursuant to section 330 of the Bankruptcy Code must be filed with the Court within 60 days of the Confirmation Date;

PLEASE TAKE FURTHER NOTICE that pursuant to the Plan, as soon as possible after the Effective Date, the Debtor shall make all Distributions set forth in the Plan.
