MOTION FOR ADMISSION OF DONALD W. FITZGERALD TO PRACTICE PRO HAC VICE, DESIGNATION OF LOCAL COUNSEL, AND CONSENT TO ACT


5. Movant certifies that he has not previously moved for admission pro hac vice to appear in a proceeding in the United States District Court for the Middle District of Florida.

Upon payment of the fee, Movant shall file a Notice of Compliance with the Clerk of the United States Bankruptcy Court.


WHEREFORE, Movant respectfully requests entry of an order authorizing his/her admission to practice and represent the Creditor in this case and any related proceedings.
