1. The basis of the debt is as follows: On various dates prior to the date of the Petition initiating this bankruptcy case Dell Marketing, L.P. (hereinafter referred to as "Dell"), supplied and sold J.L. French Automotive Casting, Inc. ("J.L. French") certain goods including computers, monitors, servers and related computer products and peripherals ("Products"). Dell supplied the Products to J.L. 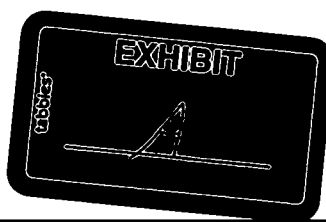


