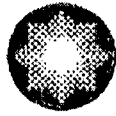
I. Background

Constellation NewEnergy—Gas Division, LLC (“CNEG”) successor in interest to Alliance Energy Services Partnership and J.L. French Corporation (“Debtor”) were parties to that certain Gas Sale and Transportation Contract (“Agreement”) dated March 27, 2001 and identified as Contract AES20131 as supplemented and amended from time to time whereby CNEG provided Debtor with gas. CNEG considers the agreement to be confidential containing confidential and proprietary business information but a true and correct copy of the agreement can be obtained by contacting counsel for CNE as listed on CNE’s proof of claim, after execution of a confidentiality agreement.

As of July 13, 2009 (“Petition Date”), Debtor owed CNEG a total of \$ 1,377.98 for gas supplied on a prepetition basis. Attached hereto and incorporated herein as **Exhibit A** is a copy of invoice supporting this amount.
