**FREUDENBERG-NOK GENERAL PARTNERSHIP'S APPLICATION FOR

Freudenberg-NOK General Partnership ("FNGP"), under 11 U.S.C. § 503(b)(9), submits this request for payment of its administrative claim. In support of this request, FNGP states:

BACKGROUND

1. On July 13, 2009 ("Petition Date"), Debtors filed voluntary petitions for relief under chapter 11 of the U.S. Bankruptcy Code ("Code").

2. On September 3, 2009, the Bankruptcy Court entered its Order (Docket No. 267), confirming Debtors' First Amended Joint Plan of Reorganization under Chapter 11 of the Code (Docket No. 245) ("Chapter 11 Plan").

3. On September 25, 2009 ("Effective Date"), the Effective Date occurred under the Chapter 11 Plan, and Debtors filed their Notice of Occurrence of Effective Date of Debtors' First Amended Joint Plan of Reorganization under Chapter 11 of the Bankruptcy Code on September 25, 2009; and (B) [sic] Deadline for Filing Certain Claims ("Notice").

4. Under the Notice and the terms of the Chapter 11 Plan, claimants must file Administrative Claims (as defined in the Chapter 11 Plan) by October 26, 2009.
