



NOTICE OF BAR DATE FOR THE FILING OF PROOFS OF CLAIM OR INTEREST

PLEASE TAKE NOTICE THAT the United States Bankruptcy Court for the District of Kansas (the "Bankruptcy Court") has entered an Order (the "Bar Date Order") establishing December 23, 2016 at 5:00 p.m. (CST) the ("General Bar Date"), subject to certain exceptions noted below, as the deadline for any party (including individuals or natural persons, partnerships, corporations, joint ventures, trusts, and governmental units) holding a claim or interest (as used in 11 U.S.C. §§101(5) and 502) involving one or more of the Debtors identified in the attached Exhibit A (the "Debtors") as of the Commencement Date identified for such Debtor in Exhibit A, to file its proof of claim or interest evidencing such claim or interest against the relevant Debtor(s).

Who Must File a Proof of Claim or Interest.

You MUST file a proof of claim to vote on any Chapter 11 plan filed by a Debtor or to share in any distributions from a Debtor's bankruptcy estate if you have a claim that arose prior to that Debtor's Commencement Date and it is not one of the types of claim described immediately below. Claims based on acts or omissions of a Debtor that occurred before that Debtor's Commencement Date must be filed on or prior to the General Bar Date, even if such claims are not now fixed, liquidated or certain or did not mature or become fixed, liquidated or certain before that Debtor's Commencement Date.

Who Need Not File a Proof of Claim or Interest.

You do NOT need to file a proof of claim on or prior to the Bar Date if you are:

- Governmental units asserting claims against the four Debtors who filed their cases on July 5, 2016;
- b. Any Person or Entity (a) that agrees with the nature, classification, and amount of such Claim or Interest set forth in the Schedules¹ and (b) whose Claim or Interest is not listed as "disputed," "contingent," or "unliquidated" in the Schedules:
- Any Person or Entity that has already properly filed a proof of claim or interest against the correct Debtor;
- d. Any Person or Entity, including any employee of Debtors, whose Claim against a Debtor previously has been allowed by, or paid pursuant to, an order of this Court;
- e. Any Person or Entity asserting a Claim allowable under §§ 503(b) and 507(a)(2) of the Bankruptcy Code as an administrative expense of the Debtors' Bankruptcy Cases (except for Claims arising under § 503(b)(9) of the Bankruptcy Code, which must be filed by the General Bar Date);
- f. Any of the Debtors that hold Claims or Interests involving one or more of the other Debtors;
- g. Any current employee, officer, director, or trustee of Debtors who asserts a Claim for indemnification, contribution, or reimbursement;

have Any Person or Entity that holds a Claim that is otherwise covered by a Master

Proof of Claim properly filed by a CMBS Lender as provided in the Bar Date

Order;

i. Any Person or Entity that asserts a Claim for rejection of an executory contract or

unexpired lease within the meaning of 11 U.S.C. §365 who is otherwise subject to

the Rejected Contract or Lease Bar Date as provided herein;

j. Any Person or Entity that asserts a Claim or Interest after any Debtor amends any

Schedules who is otherwise subject to the Amended Schedules Bar Date as

provided herein.

Rejected Contract or Lease Bar Date.

Any person or entity whose claim arises from the rejection of an executory contract or

unexpired lease within the meaning of 11 U.S.C. §365 must file such claim on or before the date

specified in the order authorizing such rejection or, if no date is specified, the later of (a) the

General Bar Date or (b) thirty (30) days after the date on which the Debtors mail notice of

the entry of such rejection order by the Court.

Amended Schedules Bar Date.

If the Debtors amend the Schedules after issuing this Notice, then any affected party shall

file a proof of claim or interest, or amend any previously filed proof of claim or interest, in

respect of such amended schedule by 5:00 p.m. (Prevailing Central Time) on the later of (a) the

Bar Date, or (b) thirty (30) days after the date on which the Debtors mail notice of the

entry of such amendment.

What to File; Completion of Proof of Claim.

- Enclosed are a proof of claim form and a proof of interest form for use in this case. If you do not use the proof of claim or interest form supplied with this Notice, any alternative form that you may submit must comply with applicable law and you are encouraged to verify with your counsel whether any alternative form that you may use complies with such law. A proof of claim form and proof of interest form also are available at the website noted in footnote 1.
- Proof of claim forms must be written in English and claims denominated in
 United States currency.
- You must identify on your proof of claim or interest the holder or holders of the claim or interest and the particular Debtor against which your claim or interest is asserted. A list of Debtors, together with their respective Commencement Dates and case numbers is attached to this Bar Date Notice as Exhibit A. If you are asserting claims or interests against more than one Debtor, you must file a separate proof of claim or interest with respect to each such Debtor. If you list more than one Debtor on your proof of claim or interest form, the Debtors will treat such form as filed against the Debtor you list first. If a Proof of Claim or Interest fails to indicate the name of a Debtor, it may be disallowed.
- All forms must be signed by the claimant or, if the claimant is not an individual,
 by an authorized agent of the claimant.

Where to File.

Except as provided for here, all proof of claim or interest forms must be filed so as to be actually received on or before the applicable Bar Date either through online Document Filing

Proof of claim or interest forms will be deemed timely and properly filed only when delivered in the form and manner as set forth herein and actually received on or before the Bar Date. Proof of claim or interest forms may not be delivered to the Claims and Noticing Agent (BMC Group, Inc.) by facsimile, telecopy or electronic mail transmission. Delivery of a claim or interest form to the Debtors' counsel will not constitute filing of a claim or interest. If you wish to receive a file-stamped copy of your proof of claim or interest, you must provide the Claims and Noticing Agent with a copy (i.e., send the original PLUS a copy thereof) of your proof of claim or interest along with a self-addressed, stamped envelope for the return of a file-stamped copy of your claim

WILL BE RELEASED FROM ANY AND ALL INDEBTEDNESS OR OTHER

LIABILITY TO THE HOLDER OF SUCH CLAIM OR INTEREST. HOLDERS OF

BARRED CLAIMS OR INTERESTS SHALL BE FORECLOSED FROM VOTING

UPON OR RECEIVING DISTRIBUTION UNDER ANY PLAN OF REORGANIZATION

OR LIQUIDATION, AND SHALL NOT RECEIVE FURTHER NOTICES IN THIS

CASE.
