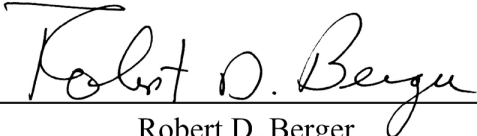

ORDER DENYING MOTION FOR ENTRY OF AN ORDER (A) DETERMINING NECESSITY FOR DISCLOSURE STATEMENT, NECESSITY FOR SOLICITATION OF ACCEPTANCES, AND CONTINUANCE OF EXCLUSIVITY UNDER 11 U.S.C. §§ 1121(b) AND 1125; (B) IF NECESSARY, GRANTING RELIEF UNDER 11 U.S.C. § 105(d) WITH RESPECT TO CONSIDERATION AND APPROVAL OF THE DISCLOSURE STATEMENT AND PLAN; AND (C) IF NECESSARY, HOLDING A HEARING ON CONFIRMATION OF THE PLAN BY FEBRUARY 26, 2018

NOW ON THIS 23rd day of January, 2018, this matter came before the Court at a hearing (the "Hearing") to consider the Debtors' Motion for Entry of An Order (A) Determining Necessity for Disclosure Statement, Necessity for Solicitation of Acceptances, and Continuance of Exclusivity Under 11 U.S.C. §§ 1121(b) and 1125; (B) If Necessary, Granting Relief Under 11 U.S.C. § 105(d) With Respect to Consideration and Approval of the Disclosure Statement and Plan; and (C) If Necessary, Holding a Hearing on Confirmation of the Plan By February 26,

2018 (ECF Doc. 1612) (the "Motion"); the Objection to the Motion (ECF Doc. 1635) filed by JD Holdings, LLC; the Objection to the Motion (ECF Doc. 1639) filed by SFI Belmont, LLC; the Objection to the Motion (ECF Doc. 1648) filed by certain secured lenders referred to in the objection as the CMBS Lenders; the Objection to the Motion (ECF Doc. 1667) filed by the City of Glendale, Arizona; and the Response to the Motion (ECF Doc. 1653) filed by certain individuals referred to in the response as the Independent Directors. No other objections were filed.¹

For the reasons set forth on the record at the Hearing, it is hereby ORDERED THAT the Motion is DENIED.
