**APPLICATION TO SHORTEN NOTICE PERIOD ON MOTION TO COMPEL
PRODUCTION OF DOCUMENTS FROM DEBTORS**

On January 19, 2018, JD Holdings, L.L.C. (“JD Holdings”) and certain of its affiliates¹ (collectively “Claimants”) filed Claimants’ Motion to Compel Production of Documents from Debtors [ECF No. 1681] (the “Motion”). Claimants, however, inadvertently failed to notice an objection deadline or hearing on the Motion.

By this motion, Claimants respectfully request that the Court exercise its broad authority to regulate notices pursuant to Bankruptcy Rule 9007 to (i) set a February 13, 2018 deadline for Debtors to file any objection to the Motion, and (ii) schedule a telephonic hearing on the Motion and any objection to take place on February 15, 2018, or as soon thereafter as the Court’s schedule permits. These dates and deadlines will not prejudice Debtors because they have had notice of the Motion since January 19, 2018, when Claimants filed the Motion on the Court’s docket and served a true and correct copy of the Motion on counsel for Debtors via email [ECF No. 1682]. The Motion concerns a discovery dispute with Debtors, and Debtors will have been afforded more time to object to the Motion than the minimum seven-day objection period set forth

in the Case Management Order [ECF No. 120].

Good cause exists to grant the relief requested. Accordingly Claimants request the Court enter an order approving this motion.
