**NOTICE OF OBJECTION DEADLINE AND OPPORTUNITY FOR A NON-
EVIDENTIARY HEARING**

PLEASE TAKE NOTICE that on January 19, 2018, JD Holdings, L.L.C. (“JD Holdings”) and certain of its affiliates¹ (collectively “Claimants”) filed Claimants’ Motion to Compel Production of Documents from Debtors [ECF No. 1681].

PLEASE TAKE FURTHER NOTICE that, on February 6, 2018, Claimants filed their Application to Shorten Notice Period on Motion to Compel Production of Documents from Debtors [ECF No. 1758] (the “Notice Period Motion”).

PLEASE TAKE FURTHER NOTICE that, if you wish to object to the relief requested in the Notice Period Motion, you must file your written objection and serve it on the Service List (as defined in the Case Management Procedures) on or before February 8, 2018.

PLEASE TAKE FURTHER NOTICE that, if an objection to the Notice Period Motion is timely filed and the Court deems necessary a non-evidentiary hearing on the Notice Period Motion, the hearing will be set for February 12, 2018 at 1:30pm (prevailing Central Time), or as soon thereafter as the Court’s schedule permits.

¹ The affiliates are Atrium Gaming, LLC; Eastgate Funding LLC; Jonesboro Funding LLC; and Atrium TRS IV, L.P. and/or Atrium Finance IV, L.P.

PLEASE TAKE FURTHER NOTICE that, if no objection to the Notice Period Motion is filed on or before February 8, 2018, the Court may grant the relief requested in the Notice Period Motion without further notice or hearing.
