STIPULATION & WITHDRAWAL OF APPLICATION

WHEREAS, on February 6, 2018, JD Holdings, L.L.C. (“JD Holdings”) and certain of its affiliates¹ (collectively “Claimants”) filed their Application to Shorten Notice Period on Motion to Compel Production of Documents from Debtors [ECF No. 1758] (the “Application to Shorten Notice Period”) and related Notice of Objection Deadline and Opportunity for a Non-Evidentiary Hearing [ECF No. 1759];

WHEREAS, the Application to Shorten Notice Period requests that the Court set a February 13, 2018 deadline for Debtors to file any objection to Claimants’ Motion to Compel the Production of Documents from Debtors [ECF No. 1681] (the “Motion to Compel”), and schedule a telephonic hearing on the Motion to Compel and any objection thereto to take place on February 15, 2018, or as soon thereafter as the Court's schedule permits;

WHEREAS, Debtors have requested that Claimants agree to extend the deadline for objecting to the Motion to Compel.

ACCORDINGLY, IT IS HEREBY STIPULATED AND AGREED, by the Parties hereto, through their undersigned counsel, as follows:

1. The Debtors may file an objection to Claimants' Motion to Compel on or before February 16, 2018;
2. On or before February 20, 2018, the parties shall contact chambers to coordinate the scheduling of a telephonic hearing on Claimants' Motion to Compel and any objection thereto;
3. Claimants hereby withdraw their Application to Shorten Notice Period [ECF No. 1759];
4. This Stipulation shall be filed on the Court's docket.
