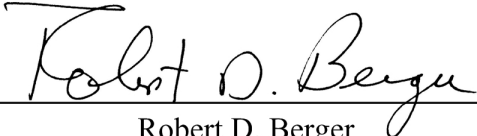

**ORDER GRANTING FIRST INTERIM APPLICATION OF STINSON LEONARD
STREET LLP FOR SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES
INCURRED AS COUNSEL TO THE DEBTORS**

This matter comes before the Court on the First Interim Application of Stinson Leonard Street LLP ("Applicant") for Services Rendered and Expenses Incurred as Counsel to the Debtors [doc. no. 789] (the "Application"), by which Applicant, as counsel to the Debtors, moved for an Order approving on an interim basis the fees and expenses incurred from June 26, 2016 through September 30, 2016 (the "First Interim Period"). The Court having reviewed the Application; the Court having determined that the relief requested in the Application is in the

best interests of Debtors, their estates, their creditors and other parties-in-interest; cause exists to grant the relief requested in the Application; it appearing that notice of the hearing on the Application was good and sufficient under the particular circumstances and that no other or further notice need be given; it appearing that are no objections to the Application; and upon the record herein; and after due deliberation thereon; therefore, it is hereby ORDERED THAT:

1. The Application is GRANTED as set forth herein.

2. Applicant is awarded, on an interim basis, fees for professional services rendered during the First Interim Period in the aggregate amount of \$887,013.00, and reimbursement for actual and necessary expenses incurred by Applicant during the First Interim Period in the aggregate amount of \$150,495.10.

3. Applicant shall be allowed to retain and apply the previous amounts paid to Applicant in the aggregate amount of \$948,806.80.

4. The Debtors are authorized to pay Applicant the pay the unpaid balance of \$88,701.30 for Applicant's unpaid approved fees during the First Interim Period.
