**ORDER APPROVING FIRST AND FINAL APPLICATION FOR THE ALLOWANCE
OF COMPENSATION FOR PROFESSIONAL SERVICES RENDERED AND
REIMBURSEMENT OF EXPENSES OF WHITEFORD, TAYLOR & PRESTON, LLP,
AS CONFLICTS AND SPECIAL COUNSEL FOR THE DEBTORS**

Whiteford Taylor & Preston, LLP (“WTP”), special conflicts and special counsel to the above-referenced debtors (the “Debtors”), filed its *First and Final Fee Application for the Allowance of Compensation for Professional Services Rendered and Reimbursement of Expenses of Whiteford, Taylor & Preston, LLP, as Conflicts and Special Counsel for Debtors* (the “Application”),¹ which came on for hearing before the above-captioned Court on January 8, 2020, at 2:30 p.m. All appearances were duly noted on the record at the hearing on the Application.

The Court having reviewed the Application and all matters submitted therewith; no oppositions having been filed; notice of the Application having been proper; the Court having stated its findings of fact and conclusions of law on the record at the hearing, which are incorporated herein by reference in accordance with Rule 52 of the Federal Rules of Civil Procedure, made applicable pursuant to Rule 9014 of the Federal Rules of Bankruptcy Procedure; and good cause appearing therefore,

IT IS HEREBY ORDERED that pursuant to 11 U.S.C. §§ 330(a) and 331, the Application is granted as follows:

1. For the period from September 16, 2019 through December 3, 2019, allowing on a final basis WTP’s professional compensation for actual, necessary services rendered in the amount of \$21,013.50, and reimbursement of actual, necessary expenses incurred in the amount of \$439.35, for a total of **\$21,452.85**.

2. WTP is authorized to pay all unpaid fees and expenses allowed pursuant to this Order from the retainer it is holding and shall return the balance of the retainer to the Debtors.
