On November 9, 2009, James C. Gianulias and Cameo Homes, the debtors and debtors-in-possession in the above-captioned substantively-consolidated chapter 11 cases (the "Debtors"), filed with the Court their "First Amended Disclosure Statement for Debtors' First Amended Plan of Reorganization (Dated November 9, 2009)" (the "Disclosure Statement"). The purpose of the Disclosure Statement is to provide "adequate information," as that term is defined in Section 1125 of title 11 of the United States Code, with respect to their proposed First Amended Plan of Reorganization (Dated November 9, 2009) (the "Plan"), filed concurrently with the Disclosure Statement. If the Disclosure Statement is approved by the Court: (1) a hearing will be set to consider confirmation of the Plan, and (2) the Debtors will submit the Disclosure Statement, in the form

approved by the Court, and the Plan, as proposed at the time of distribution of the Disclosure Statement, to their creditors and interest holders and shall request that all appropriate parties vote to accept the Plan.

NOTICE IS HEREBY GIVEN pursuant to Rule 2002 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") that:

1. A hearing to consider the Disclosure Statement has been set for December 16, 2009, at 3:00 p.m. (PDT) before the Honorable Robert N. Kwan, United States Bankruptcy Judge, in Courtroom 5D at the Ronald Reagan Federal Building and United States Courthouse located at 411 West Fourth Street, Santa Ana, California 92701 (the "Hearing").

2. Pursuant to Bankruptcy Rule 3017(a), the Debtors will serve copies of the Plan and the Disclosure Statement on the parties referenced in paragraph 4 below and any other party who requests in writing a copy of the Plan and the Disclosure Statement. Requests for copies of the Plan and the Disclosure Statement shall be honored only if made in writing and mailed, delivered, or transmitted via fax, or e-mailed to the following address:
