A debtor is the person, corporation, or other entity that has filed a bankruptcy case.

A claim is the creditor's right to receive payment on a debt that was owed by the debtor on the date of the bankruptcy filing. See 11 U.S.C. §101 (5). A claim may be secured or unsecured.

#### Proof of Claim

#### **Unsecured Claim**

An unsecured claim is one that does not meet the requirements of a secured claim. A claim may be partly unsecured if the amount of the claim exceeds the value of the property on which the creditor has a lien.

unsecured claims that are paid from the available money or property in a bankruptcy case before other unsecured claims.

The undersigned, jointly and severally ("Maker"), for value received, promises to pay to the order of INTERVEST-MORTGAGE INVESTMENT COMPANY ("Lender") the principal sum of Nine Million Nine Hundred Sixty Thousand Dollars (\$9,960,000.00), and to pay interest on the unpaid principal thereof from the date of disbursement of principal at the rates hereinafter set forth, together with all costs and fees, including attorneys' fees, incurred by Lender in enforcing the obligations of this Note. The principal hereof and interest and premium, if any, hereon are payable to Lender at 5005 S.W. Meadows Road, Suite 400, Lake Oswego, Oregon 97035, or such other place as Lender may direct, in such coin or currency of the United States of America as at the time of payment shall be legal tender for the payment of public and private debts. Principal and interest shall be payable as follows:

a. Each loan advance shall bear interest from the date of such advance. The annual rate of interest shall be equal to three and one half percent (3.50%) in excess of the one month LIBOR Rate (London Interbank Offer Rate) as published in the *Wall Street Journal* at the date of closing. It is not itself necessarily a rate commonly charged to any class of borrowers, nor is it necessarily the lowest or best rate offered by Lender.

The entire principal and any accrued interest on this Note shall be paid in full b. on or before October 1, 2007; provided however, that so long as Maker is not then in default, nor has been in default beyond the applicable cure period, under any of the provisions of any of the Loan Documents referred to herein, or with respect to any payment provided for herein, Maker may elect to (i) extend the maturity date of this Note to April 1, 2008 (first extended maturity date), upon giving Lender notice in writing of its intention to extend the maturity date at least thirty (30) days prior to the maturity date of this Note and upon paying Lender the sum of Forty-Nine Thousand Eight Hundred Dollars (\$49,800.00) at least thirty (30) days prior to the maturity date, in consideration for the extension period, and (ii) extend the maturity date of this Note to October 1, 2008, upon giving Lender notice in writing of its intention to extend the maturity date at least thirty (30) days prior to the first extended maturity date of this Note and upon paying Lender the sum of Forty-Nine Thousand Eight Hundred Dollars (\$49,800.00) at least thirty (30) days prior to the first extended maturity date, in consideration for the extension period. In the event that Maker elects to extend the maturity date subject to the requirements of this paragraph, all terms and conditions of this Note and the Loan Documents referred to herein shall remain in full force and effect.

Maker shall have the right, at any time, to prepay the whole or any part hereof without penalty. Any partial prepayment shall be applied against the principal amount outstanding and shall not postpone the due date of any subsequent installments or change the amount of such installments, unless Lender shall otherwise agree in writing.

Following default in the payment of any installment of interest when due hereunder, or default under any of the covenants or conditions of the Deed of Trust which secures this Note or any other document executed in connection with or to secure this Note (the "Loan Documents") and expiration of the applicable cure period, Lender may elect to (i) declare the whole amount then unpaid due and collectible, whether due by lapse of time or not, and/or (ii) declare an increase in the rate of interest so that this Note shall thereafter bear interest at the rate contained herein, plus three percent (3.00%) per annum, initially determined on the date of default and adjusted as any variable rate changes.
