- 2. Pursuant to 11 U.S.C. § 546, the last date to file an avoidance action is two years after the entry of the Order for Relief.
- Pursuant to Debtors' proposed Plan of Reorganization, the responsibility for prosecuting avoidance actions will be assigned to the Creditors' Trust.
- 4. The Confirmation hearing is currently set for July 9, 2010 and the parties anticipate that the Confirmation Order will be entered shortly thereafter.
- 5. In order to allow the Committee and, thereafter, the Creditors' Trust time to review payments to Gianulias to determine if an avoidance action is necessary, the Committee has requested and Debtors and Gianulias have agreed that the time to file such action shall be extended for 90 days, to and including September 29, 2010.

WHEREFORE, IT IS HEREBY STIPULATED AND AGREED that the deadline for the Committee and, thereafter, the Creditors' Trust to file an avoidance action against Gus Gianulias is extended to September 29, 2010.
