INSTRUCTIONS FOR PROOF OF CLAIM FORM

The instructions and definitions below are general explanations of the law. In certain circumstances, such as bankruptcy cases not filed voluntarily by the debtor, there may be exceptions to these general rules.

Items to be completed in Proof of Claim form

Court, Name of Debtor, and Case Number: Fill in the federal judicial district where the bankruptcy case was filed (for . example, Central District of California), the lumbruptcy debtor's name, and the bankruptcy case number. If the creditor secrived a notice of the case from the bankruptcy court, all of this information is located at the top of the notice.

Fill in the name of the person or entry asserting a claim and the more and address of the person who should stocke natices issued during the bushroptey case. A separate space is provided for the payment address if it differs from the notice address. The creditor has a continuing obligation to heep the count informed of its current address. See Federal Rule of Bankruptcy Procedure (FRBP) 2002(g).

State the total amount swed to the coeditor on the date of the Bankruptcy filing. Follow the instructions concerning whether to complete items 4 and 5. Check the box if interest or other charges are included in the claim...

DEFINITIONS

Debter

A debtor is the person, corporation, or other entity that has filed a bankruptcy case.

A creditor is the person, corporation, or other entity wed a debt by the debtor on the date of the benkruptcy filing.

A claim is the creditor's right to receive payment on a debt that was owed by the debter on the date of the bankruptcy filing. See 11 U.S.C. \$101 (5). A class may be secured or unsecured.

Proof of Clair

A proof of chains is a form used by the credite indicate the amount of the debt sweet by the debtor on the date of the bankruptcy filing. The creditor must file the form with the clerk of the same bankruptcy court in which the bankruptcy case w

Secured Claim Under 13 U.S.C. (\$366(a) of the debtor. The chain is secured so hing as the creditor has the right to be paid from the property prior to other creditors. The amount of the secured claim cannot exceed the value of the property. Any amount owed to the creditor in excess of the value of the property is an unsecured claim. Examples of licus on property include a mortgage on real estate Or a accurity interest in a car.

A lien may be voluntarily granted by a debtor or may be obtained through a court proceeding. In some states, a court judgment is a lieu. A claim also may be secured if the creditor owes the debtor money (bas a right to sear).

Descripted Chi

An unsecured claim is one that does not meet the irements of a secured claim. A claim may be partly suscered if the amount of the claim exceeds the value of the property on which the creditor has a

Evidence of perfection may include a mortgage, lien, certificate of title, financing statement, or other document showing that the lien has been filed or recorded

(www.pacer.psc.uscourts.gov) for a small fee to view your filed proof of claim.

Offers to Purchase a Claim

Certain entities are in the business of purchasing claims for an amount less than the face value of the claims. One or more of these entities may contact the creditor and offer to purchase the claim. Some of the easily be confused with official court documentation or communications from the debtor. These entities do not represent the bankruptcy court or the debtor. The creditor has no obligation to sell its claim. However, if the creditor decides to sell its claim, any transfer of such claim is subject to FRBP 3001(e), any applicable provisions of the Bankruptcy Code (11 U.S.C. § 101 of seq.), and any applicable orders nkruptcy court.
