**AMENDED NOTICE OF MOTION OF JACOB PEARLSTEIN, LLC FOR  
ALLOWANCE OF ADMINISTRATIVE EXPENSE CLAIM**

**PLEASE TAKE NOTICE**, that upon the motion of Jacob Pearlstein, LLC (“JPLLC”), as Landlord under that certain unexpired lease of nonresidential real property (the “Lease”) with Jennifer Convertibles, Inc. (“Debtor”), as Tenant, for the Demised Premises located at 96 Dogwood Road, Roslyn, New York 11576, for Allowance and Payment of a Priority Administrative Expense Claim Pursuant to 11 U.S.C. §§ 507(a)(2), 503(b) and 365(b)(4) (the “Motion), the undersigned will move this Court for entry of an Order Granting JPLLC an Administrative Expense Claim in the amount of \$5,879.90 for unpaid administrative rent due under the Lease and directing the Debtor to promptly pay the amount due to JPLLC, and for such other, further and different relief as this Court deems just and proper (the “Motion”).

**PLEASE TAKE FURTHER NOTICE**, that objections, if any, to the relief sought in the Motion shall conform to the Federal Rules of Bankruptcy Procedure and the Local Bankruptcy Rules, shall be in writing, shall state with particularity the grounds therefor, and shall be filed with the Bankruptcy Court for the Southern District of New York, electronically in accordance with General Order M-242 by registered users of the Bankruptcy Court's electronic case filing system and by all other parties in interest on a 3.5 inch disk, preferably in Portable Document Format ("PDF"), Word Perfect, or any other Window-based word processing format, with a hard copy delivered directly to the Chambers of the Honorable Allan L. Gropper, United States Bankruptcy Judge, and shall be served (in hard copy) so as to be received by **4:00 p.m. (New York time) on or before November 22, 2010**, upon counsel for JPLLC, Certilman Balin Adler & Hyman, LLP, 90 Merrick Avenue, East Meadow, New York, 11554, Attn: Richard J. McCord, Esq.; and the Office of the United States Trustee, 33 Whitehall Street, 21<sup>st</sup> Floor, New York, New York 10004.
