(“TM Capital”), as financial advisors to Jennifer Convertibles, Inc. and its affiliated debtors, as debtors in possession, hereby submits its monthly statement of services rendered and

expenses incurred for the period of November 1, 2010 through and including November 30, 2010 (the "Statement Period").

1. TM Capital is owed monthly fees in the amount of \$25,000.00 for the Statement Period (see attached invoice).

2. TM Capital is owed monthly expenses in the amount of \$2,203.34 for the Statement Period (see attached invoice).

3. Pursuant to the Interim Compensation Order, the fees payable to TM Capital for the Statement Period, after adjustment of the 20% holdback, are \$20,000.00.

4. Accordingly, TM Capital requests payment for the Statement Period in the total amount of \$22,203.34, which includes \$20,000.00 of fees (80% of total fees) and \$2,203.34 of expenses (100%).

5. TM Capital respectfully requests that such amounts be paid in accordance with the Interim Compensation Order.
