11 U.S.C. § 365, EFFECTIVE AS OF THE EFFECTIVE DATE OF THE CHAPTER 11
PLAN OF REORGANIZATION**

PLEASE TAKE NOTICE that J.W. Mays, Inc. ("Mays") hereby withdraws its limited objection [Docket # 415] (the "Limited Objection") to the *Debtors' Motion For Authority To (I) Enter Into Amended Non-Residential Real Property Leases Pursuant To 11 U.S.C. § 363 And (II) To Assume Amended Non-Residential Real Property Leases Pursuant 11 U.S.C. § 365, Effective*

PLEASE TAKE FURTHER NOTICE that Mays reserves its right to object to the Amended Cure Schedule, including, but not limited to, the amounts required by the Debtors to cure all defaults, provide reimbursement for all of the actual pecuniary losses incurred by Mays, including, but not limited to, attorneys’ fees and costs expended in connection with the Debtors’ chapter 11 case, and any other amounts which may be due Mays.
