PLEASE TAKE FURTHER NOTICE, that any responses or objections to the Second Omnibus Objection, must be in writing, conform to the Bankruptcy Rules and the Local Rules of the Bankruptcy Court, and be filed with the Bankruptcy Court electronically in accordance with General Order M-242 (General Order M-242 and the User's Manual for the Electronic Case Filing System ("ECF") can be found at www.nysb.uscourts.gov, the official website for the Bankruptcy Court), by registered users of the Bankruptcy Court's filing system and, by other parties in interest, on a 3.5 inch disk, preferably in Portable Document Format (PDF), WordPerfect or any other Windows-based word processing format (with a hard copy delivered directly to Chambers of Judge Gropper) and shall be served in accordance with General Order M-242 so that they are received no later than **4:00 pm** (prevailing Eastern Time) on **March 16, 2011** upon: (i) counsel to the Debtors; (ii) Office of the United States Trustee for the Southern District of New York; (iii) counsel to the Official Committee of Unsecured Creditors; (iv) the SEC; (v) any other party who has filed a notice of appearance in these cases; and (vi) any party listed on Exhibit A, B, or C to the Second Omnibus Objection. Only those parties who have timely filed and served an objection to the Second Omnibus Objection may be heard at the hearing.
