BUDGET PAYMENT PLAN

The Budget Payment Plan is designed to offset the effects of higher winter gas bills and allows you to budget approximately the same amount each month. Your budget payment will be more than your actual bill during the months your gas use is low, but less than your actual bill when your gas use is high. Residential customers may enroll at any time. Commercial customers may enroll May through October.

AUTOMATIC BANK DRAFT PROGRAM

The Bank Draft plan takes the bother out of paying your gas bill by automatically deducting the amount due from your checking or savings account each month. There's no check to write, no stamp to buy, no trip to an office and no worry about bills while you are out of town.

CHOICEPAY

ChoicePay is a fast, economical and secure way to pay your Oklahoma Natural Gas bill. It lets you deduct the amount of your gas bill from your checking or savings account with a simple phone call to our automated voice service. You may also use your Visa, MasterCard or Discover Card. It's so easy, you'll wish you could pay all your bills this way.

PREFERRED DUE DATE

This plan allows eligible customers to select the time period in which the gas bill will be due. It is designed especially for those who depend on a social security, pension or disability check as their main source of income.

EXTENDED PAYMENT PLAN

With the Extended Payment Plan, you can pay out your account over a period of time. The Plan helps many customers cope with the larger bills received during the

winter. When you see a bad payment record on your problem bill, call us for more information.
