IMPORTANT NOTICE – MOTOR VEHICLES

The County cannot change a name or tag fee provided by DMV. Changes must be made at DMV branch office.

The County is not authorized to collect any late registration penalties. Please do not include penalties with payment of taxes. You must contact DMV for payment or late penalties or to apply for senior citizens discount or any other change in fee amount.

Penalty applies to all taxes on date shown, regardless of circumstances or receipt of tax notice. Tax receipts are null and void when payment is made by a check that fails to clear the bank.

On Motor Vehicle Taxes the following applies:

If you own this vehicle you must pay the property taxes to the county in which you live. Before making payment PLEASE verify the vehicle description and district for accuracy. If not correct, bring your vehicle registration to the County Auditor's Office. If you replace this vehicle before the expiration of your tags, you may choose to transfer the tags to the new vehicle and not pay property tax on the new vehicle until the expiration date of the tags. If you sell this vehicle and do not transfer tags, you may return the tags with proof of sale and this receipt to the Auditor's Office, marked PAID, for a prorated refund.

TO APPEAL THE ASSESSMENT (OR TO GET HIGH MILEAGE DEDUCTION) ON THIS VEHICLE, THE APPEAL MUST BE IN WRITING TO THE AUDITOR BEFORE PAYMENT DUE DATE.

"It shall be unlawful for any person to use the treasurer's receipt to obtain plates unless all municipal personal property taxes due to the county of his residence on any vehicles now or previously owned by the applicant have been paid. Any person who knowingly violates the provisions of this section shall be deemed guilty of a misdemeanor and, upon conviction shall be fined not more than two hundred dollars. Each day shall constitute a separate offense."
