On 02/14/2002, the Debtor filed a motion for an order to distribute funds of certain deferred compensation plans to the plan participants (docket #702). The agenda for the regular 03/06/2002 omnibus hearing indicated that the Official Financial Institutions' Committee requested this matter be continued to 03/20/2002. The agenda also stipulated that the period for filing objections was extended to 03/13/2002 for this committee only. On 03/18/2002, the Official Financial Institutions' Committee filed an objection on the basis that many of the same management workers are covered under the \$150 million key employee retention bonus program (docket # 1602). This claim seeks distribution to the Creditor of the entire balance of the Creditors' deferred compensation account (\$34,103.48 as of 03/20/2002) regardless of the final disposition of the Debtors' motion for the following reasons:

1. The objection of the Official Financial Institutions' Committee was filed after the objection deadline.
2. The Creditor is no longer an employee of the Debtor and is not covered under the key employee retention program cited by the Official Financial Institutions' Committee as the basis for their objection.
3. Under the terms of the deferred compensation plan and the Creditors' elections, a plan distribution was due to the Creditor as of 01/01/2002. A number of plan participants expecting distributions as of this date received them while the Creditor did not. This, in effect, discriminates against those participants who did not receive their distributions.
4. In their bankruptcy filing, the Debtor listed assets of \$16 billion and liabilities of \$11 billion. This would seemingly indicate that the Debtor would not need the assets of the deferred compensation plans to settle claims.

The attached documents provide additional evidence to substantiate this claim.

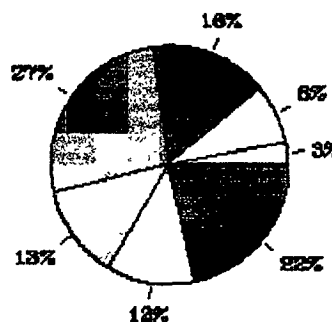
