RE: Kevin Meiswinkel v. KMART

Dear Ms. McCarthy:

Per your request, enclosed please find a copy of all medical records.

Liability is clear. Mr. Meiswinkel stepped on fixture that had been thrown under a clothing display at K-mart. The fixture went through his boot. He fell forward sustaining a serious cervical and lumbar injury in addition to the puncture wound on the foot.

The cervical disc herniation at C5-C6 was confirmed by MRI and shown to be indenting the thecal sac and cord. **An Anterior Cervical Discectomy C5-6 and arthrodesis with allograft and instrumentation was performed on February 5, 2002.**

Mr. Meiswinkel continues to have pain in his neck and restriction of movement. His left bicep reflex is absent. These conditions are permanent and may very well worsen over time. They interfere with his everyday living including his ability to interact with his children.

As discussed, Keivu Knox previously agreed to have Judge Barry Weinberg mediate this matter here in New Jersey. Should we be unable to resolve this matter shortly, kindly advise of the date this matter will be mediated here.
