
NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

Debtors, as distribution agent under the Kmart Corporation Plan of Reorganization, are directed to promptly direct Computershare, agent, (1) to take such acts as necessary to cause a distribution to Cesce MEXICO, S.A. de C.V., f/k/a Seguros Bancomext S.A. de C.V., of all shares presently or in the future distributable on Claim 26578, the amount of shares presently being 3,072; provided that Cesce MEXICO, S.A. de C.V. shall furnish to Computershare any Form W-8 or W-9 statements or other tax documents as required by Computershare to make the distribution; and (2) to show the holder of Claim 26578 as having the following name and address:

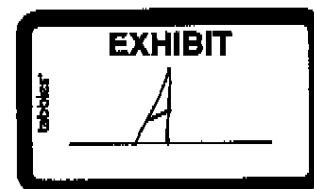

STIPULATION

Cesce MEXICO, S.A. de C.V. f/k/a Seguros Bancomext, S.A. de C.V. ("Seguros") and Private Manufacturing, Inc. ("Private") stipulate as follows:

1. Private filed Proof of Claim #26578 in this Bankruptcy Case, which was allowed as an unsecured claim (the "Claim") in the amount of \$1,520,000 pursuant to an order entered by this Court on April 13, 2004 (Docket No. 23791). On January 9, 2006, Seguros filed its Notice of Transferred Claim (Docket No. 29439) asserting that the Claim was assigned to it.
2. On January 17, 2006, Private filed its Objection to the Notice of Transferred Claim (Docket No. 29547), and the Notice and Objection have been carried on the Court's docket as a contested matter (the "Contested Matter").
3. The parties have now agreed that, to the extent provided below, the Claim should be transferred to Seguros, and that Seguros is entitled to all of the stock currently held for payment of this Claim ("Held Stock"), and any further distribution that the holder of this Claim should become entitled to in the future.
4. The name and address of record for Seguros, as holder of Claim #26578, is to be noted on the claims docket as follows:

The parties ask that the Debtors, as distribution agent under the Kmart Corporation Plan of Reorganization, be directed to promptly direct Computershare, agent, to take such acts as necessary to cause a distribution to Cesce MEXICO, S.A. de C.V. of all shares presently or in the future distributable on Claim 26578, the amount of shares presently being 3,072; provided that Cesce MEXICO, S.A. de C.V. shall furnish to Computershare any Form W-8 or W-9 statements or other tax documents as required by Computershare to make the distribution.

6. The parties intend that the Contested Matter be now closed, but that each party reserve the right to pursue all claims against the other related to this Contested Matter, or any other claims between the parties, in any other appropriate forum.
