**NOTICE OF REPORT BY GETZLER HENRICH & ASSOCIATES LLC OF  
COMPENSATION EARNED AND EXPENSES INCURRED FOR THE  
PERIOD OF APRIL 1, 2018 THROUGH APRIL 30, 2018**

On May 17, 2018, the **Report by Getzler Henrich & Associates LLC of Compensation Earned and Expenses Incurred for the Period of April 1, 2018 through April 30, 2018** (the “Report”) was filed with the Court. The Report seeks the approval of payment for professional services rendered to the Debtors in the amount of \$12,305.00, together with reimbursement of expenses in the amount of \$40.00.

On February 7, 2018, the *Order Authorizing the Debtor (I) to Retain Getzler Henrich & Associates LLC to Provide Interim Management Services and Provide the Debtor a Chief Restructuring Officer and Additional Personnel and (II) to Designate William H. Henrich and Mark G. Samson as the Debtor’s Chief Restructuring Officers, Nunc Pro Tunc to the Petition Date* [Docket No. 119] (the “Retention Order”) was entered by the Court.

Pursuant to the Retention Order, you are required to file a response (the “Response”), if any, to the Report with the Clerk of the United States Bankruptcy Court for the District of Delaware, 824 Market Street, 3<sup>rd</sup> Floor, Wilmington, Delaware 19801 on or before **May 31, 2018 at 4:00 p.m. (prevailing Eastern Time)** (the “Response Deadline”).

At the same time, you must also serve a copy of the Response upon the applicant so as to be received by the Response Deadline.
