PLEASE TAKE FURTHER NOTICE THAT PURSUANT TO THE ORDER ESTABLISHING PROCEDURES FOR INTERIM COMPENSATION AND REIMBURSEMENT OF EXPENSES OF PROFESSIONALS [DOCKET NO. 124], IF NO OBJECTIONS ARE FILED AND SERVED IN ACCORDANCE WITH THE ABOVE PROCEDURES, AND UPON THE FILING WITH THE BANKRUPTCY COURT OF A CERTIFICATION OF NO OBJECTION, THE DEBTOR IS AUTHORIZED TO PAY THE APPLICANT 80% OF THE REQUESTED INTERIM FEES AND 100% OF REQUESTED INTERIM EXPENSES WITHOUT FURTHER ORDER OF THE COURT. ALL FEES AND EXPENSES PAID TO THE APPLICANT ARE SUBJECT TO FINAL APPROVAL BY THE COURT.
