DECLARATION OF CHARLOTTE G. FOSTER

1. I, Charlotte G. Foster, am employed by the Centers for Medicare & Medicaid Services (CMS), United States Department of Health and Human Services. I have been employed with CMS since 1986. Currently, I am the Associate Regional Administrator, Division of Financial Management and Fee for Service Operations, Region III (in Philadelphia). I have held this position since 2003. Among my responsibilities is the oversight of payment and overpayment issues for bankruptcy cases filed by Medicare providers and suppliers in the state of Delaware. I am authorized to make this request for payment of administrative expenses pursuant to 11 U.S.C. § 503(b)(1)(A) on behalf of CMS.

2. The statements contained in this declaration are based on my personal knowledge, on information supplied to me by other employees of CMS and its contractors, on records, and on information available to me in my official capacity.

3. CMS is an operating component of the United States Department of Health and Human Services and is responsible for the administration of the Health Insurance for the Aged and Disabled Program, otherwise known as Medicare. Under Part B of the Medicare Program, CMS pays for laboratory services (among other items and services) provided to Medicare beneficiaries.

4. On October 25, 2013, Laboratory Partners, Inc., and six associated companies (the Debtors) filed for bankruptcy under Chapter 11 of the Bankruptcy Code. These cases are being jointly administered.

5. Most of the Debtors in this case are "suppliers" in the Medicare program. See 42 U.S.C. § 1395m, and are parties to Medicare Enrollment Agreements, 42 U.S.C. § 1395cc(g); 42 C.F.R. §§ 424.500–424.570. The Debtors provide laboratory services to Medicare

beneficiaries, and receive Medicare payment for those services, under the Medicare supplier identification numbers listed with the related administrative claim amount, in paragraph 11, below.

6. Medicare Suppliers submit claims and receive Medicare payment from the Medicare Administrative Contractor (MAC) assigned to process and pay claims for the geographic region in which the Medicare beneficiaries reside.

7. The Medicare Enrolled Debtors have submitted claims to five MACs: Wisconsin Physicians Service, CGS Administrators, LLC, Novitas Solutions, Inc., National Government Services, and Palmetto GBA Railroad Medicare.

8. The Medicare statute does not permit Medicare to pay for items and services that “are not reasonable and necessary for the diagnosis or treatment of illness or injury or to improve the functioning of a malformed body member.” 42 U.S.C. § 1395y(a)(1)(A); *see* 42 C.F.R. § 410.12(a).

9. MACs pay most Part B claims upon receipt of a minimum set of information. Post-payment, the MACs review the claims to verify that the claims meet all Medicare eligibility requirements. 42 C.F.R. § 421.200(d). If the claims are not eligible for Medicare payment, the MACs determine overpayments. In its notice of overpayment, the MAC informs the supplier of its right to appeal the overpayment determination.

10. The MACs may reopen all claims for up to four years after the initial determination, and reopen claims at any time if there is reliable evidence of fraud. 42 C.F.R. § 405.986.

11. Based on records made contemporaneously and kept in the ordinary course of CMS’s business, on August 15, 2014, totals of post-petition overpayments for services provided between December 10, 2013 and July 25, 2014 by each Debtor and its associated Suppliers are as follows:

The amounts listed above constitute the Debtors' outstanding liquidated post-petition debt as of the date stated, but the Debtors may accrue further post-petition liability.

12. Based upon the Court's Order dated 10/29/2013, entitled "Order (I) Authorizing Debtors To (A) Continue Insurance Policies, Premium Financing Agreement, And Agreements Relating Thereto, And (B) Honor Certain Prepetition Obligations In Respect Thereof; And (II) Granting Related Relief, and agreements with Debtors," Debtors have permitted CMS and its contractors to recoup Medicare overpayments. The balances here indicate amounts not yet recouped by CMS and its contractors as of August 15, 2014.

13. However, because of post-payment claim review and potential reopening, additional amounts may be determined in the future when CMS is no longer making payments to the Debtors. Therefore, CMS reserves the right to assert subsequently discovered liabilities, and to amend this administrative claim.


14. This claim reflects the estimated liability of the Debtors' to CMS. This amount will change when the MACs determine additional overpayments.

15. Moreover, the filing of this claim is not to be construed as a waiver of the right of the United States, or of any agency or instrumentality thereof, to follow any property, or the proceeds thereof, into the hands of whomsoever the same may be, including the receiver or trustee in bankruptcy; nor shall it be construed as a waiver of any other claim or right of action or setoff or recoupment or of any other right whatsoever that the United States, or any agency or instrumentality thereof, has or may have against the Debtors, the receiver, the trustee, or any other person.

The United States Attorney for the District of Delaware is designated to receive and accept service of all notices and papers affecting this claim, except that such notices as are required to

be mailed to the head of the Government agency involved, pursuant to 11 U.S.C. ' 342, should also be furnished.

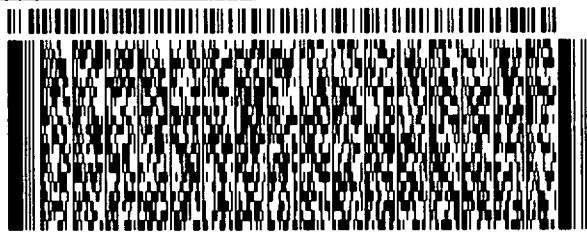
