Med Auction, Inc. ("Med Auction") hereby files this proof of claim (the "Proof of Claim") in the chapter 11 bankruptcy case of Body Contour Ventures, LLC (the "Debtor"), debtor in Bankruptcy Case No. 19-42510-pjs filed in the United States Bankruptcy Court for the Eastern District of Michigan.

**Basis for Claim**

1. On February 22, 2019 (the "Petition Date"), the Debtors, including the Plaintiff (the "Debtors") each filed a voluntary petition for bankruptcy under Chapter 11 of the United States Code.

2. On March 29, 2018, the Debtor and Med Auction entered into a Purchase Agreement wherein the Debtor agreed to sell 10 Brand New Thermage FLX Machines to Med Auction for the total purchase price of \$540,000.00 (the "March Agreement"). See Copy of the March Agreement attached as "*Exhibit 1*".

3. Pursuant to the March Agreement, Med Auction wired the following payments to the Debtor towards the purchase price under March Agreement:

4. The Debtor failed to deliver the agreed equipment to Med Action pursuant to the March Agreement and therefore, breached its contractual obligations under the March Agreement.

5. On or before October 10, 2018, the Debtor proposed to sell 20 Brand New Ulthera Machines to Med Auction in lieu of partial payment of the debt owed by the Debtor to Med Auction under the March Agreement. Also, on or before October 20, 2018, the Debtor delivered 10 Brand New Ulthera Machines to Med Auction.

6. The Ulthera Machine is an old technology and is inferior to Thermage FLX Machine. The Thermage FLX Machine as agreed to be delivered to Med Auction under the March Agreement was a latest 2019

model product and therefore superior in quality as compared to the Ulthera Machine which was initially launched in the year 2010. Being the latest technology and therefore, higher in demand, the price of a Thermage FLX Machine is higher as compared to the Ulthera Machine. A proof indicating the pricing of an Ulthera Machine is attached as “*Exhibit 3*”.

7. On October 10, 2018, only for accounting purposes, Med Auction and the Debtor entered into a Purchase Agreement wherein the Debtor agreed to sell the remaining 10 Brand New Ulthera Machines as agreed, to Med Auction for the total purchase price of \$500,000.00 (the “October Agreement”). See the Copy of the October Agreement attached as “*Exhibit 4*”. After about October 10, 2018, the Debtor delivered the agreed equipment to Med Auction.

8. As of the Petition Date, the Debtor owed \$540,000 to Med Auction for the breach of contract amounting to failure of the Debtor to deliver the agreed products under the March Agreement.

9. The debt owed by the Debtor to Med Auction under the March Agreement and the debt owed by Med Auction to the Debtor under the October Agreement essentially relate to the same transaction between the parties.

10. Accordingly, Med Auction now files this Proof of Claim in Debtor’s bankruptcy case asserting its right to setoff or recoupment of a debt owed by the Debtor to Med Auction.

#### **Reservation of Rights**

Med Auction reserves the right to further supplement or amend this Proof of Claim, including for the purpose of adding specific or additional sums related to the matters described herein. Nothing herein or otherwise, including, but without limitation, any later appearance, pleading, claim, or action, is intended or shall be deemed to be a waiver, release, or modification by Med Auction of rights, remedies, claims, actions, defenses, setoffs, or recoupments to which Med Auction is or may be entitled, all of which are hereby expressly reserved. Med Auction reserves the right to amend, supplement, or modify this Proof of Claim and its supporting documents from time to time as may be necessary or appropriate in accordance with changes in fact or law.
