To Whom it May Concern:

I Started using LightRX's services in let 2017 at a location near my home in Orem, Utah.

I purchased several thousand dollars' worth of goods and services from the company, and many different treatment series. Sometime in 2018, before I was able to use all of the services I have bought and paid for, they closed the Orem location with no notice. I called to make an appointment and was told the store was closed and that I would have to travel to another location (about an hour's drive away) to complete my services. At that time I asked for my money back and was refused.

I was later told I could have only \$600 of my funds back, but they never honored that despite promising several times it would be taken care of. I made the hour long trip one time to receive one treatment, but I have a very busy schedule and I am just not available to travel that much. This is one of the major reasons I chose this company to begin with, was that they were very close to my location and I would be able to go there on my lunch break for treatment.

They have now closed all locations in my state, without any notice, contact, or offers of refund or assistance of any kind.

I truly feel I should get all of my money returned to me, because of the months and months of begging for any kind of resolution, not to mention I feel the treatments and products were completely ineffective and fraudulent. However, I would be content just to have the funds for the goods and services I never used returned to me.

I have included the last email I received from the second location, naming some of the services I had remaining, they are:

1 Sculpsure Submental \$749

1 VIVA facial treatment \$499

4 IPL Photofacials \$200

You can see in the emails where I also ask about botox and a gift card. I purchased 60 units of botox and only used half of them. After the first injection I received, Light RX never had an injector employed, so I was unable to use the rest of the purchased botox. I also bought a \$700 gift card that I was not ever able to use, I have included a copy of the giftcard as well.

My total for unused goods and services is \$2,448.00

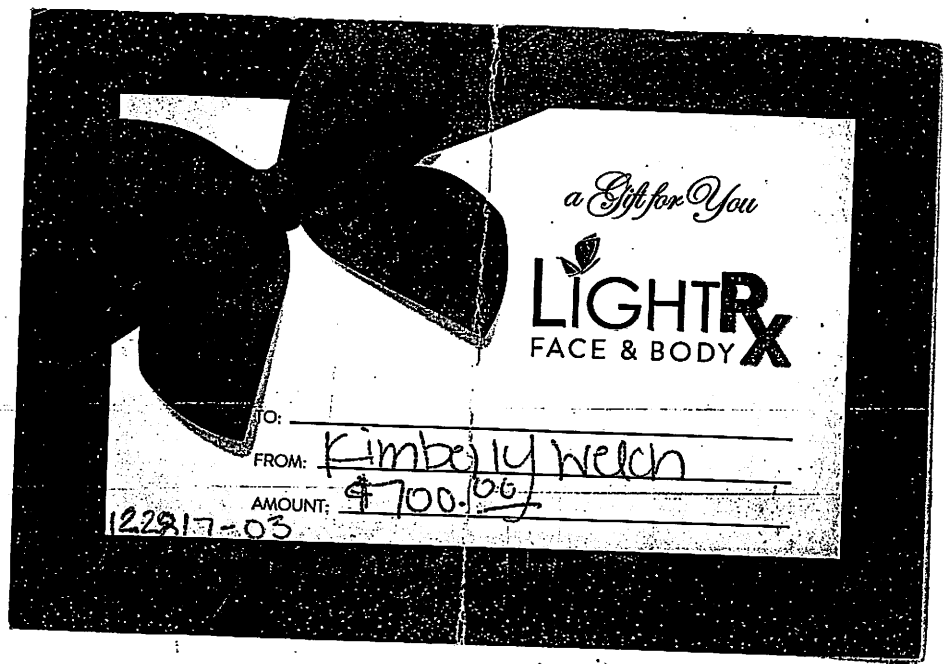

Good Afternoon,

My name is Kimberly Welch, I was a client at your Orem, Utah location. I have used your services for approximately \$5000 worth of treatments. I had purchased several packages and was in the process using those programs when LightRX closed that branch and merged with the location in Draper, Utah, about an hour-plus round trip from my home. At the time, I felt like because of the inconvenience, the appropriate response from LightRX would be to let me have a refund of the value of my remaining treatments. The treatments I had paid for and not used when the store closed were: Botox units (I tried multiple times to use these, but there was no injector beyond the very first time I used it who could perform the injections), a Legacy treatment, Viva treatments, and RF treatments, and several hundred dollars still remaining on a gift card I had purchased.

I asked the manager at the time if Light RX would consider giving me a refund since they closed the location that was close to me, and I don't really have time to travel that far every week to complete these treatments. She got in touch with upper management and was told that the only thing they were willing to refund was the one Legacy treatment I had not used. She told me they would refund \$600.

During this same time period, I had paid off and closed the account I had originally opened to pay for my treatments at LightRX. I waited for the refund and was told because I had closed the account and paid it in full, that is where they had tried to refund the money, were not successful, but did not take any further action to help get me the refund. I spoke with the manager again, and she said she would contact upper management once more, and she got back to me and said that a check would be issued to me and sent to my home.

It's been since January of this year, and I have still not received any refund from Light RX, I have asked multiple times, and gotten the same answer, "we will contact corporate and see what the problem is."

I would like LightRX to re-consider and refund me the money for the all of the services I did not use, and will not be able to use without great inconvenience, or at the very least honor the refund that was promised to me 10 months ago.

Thank you for your time and for your help, I look forward to your reply.
