- I, Marisol Rivera, being first duly sworn, declare under penalty of perjury that the following is true and correct.
 - 1. I make this declaration of my own personal knowledge.
 - 2. I live at #308 Williams Delight, Frederiksted, St. Croix.
 - On May 12, 2021, there was an oil spew from Limetree Bay that spewed oil on my property including my roof. As a result my cistern water became contaminated by the oil product that had covered my roof.
 - 4. Officials from Limetree Bay showed up at my residence two weeks after the oil spew advising that they needed permission to inspect my property for oil.
 - 5. Upon completion of her inspection, she stated that there was oil found on our property and gave me two cases of water.
 - The officials stated that an adjuster would come by to further assess the damage to our property.
 - 7. By this time, I had already started to develop bumps on my skin that itched and turned into red bumps that bled. I also experienced burning in my throat.

- 8. On June 16, 2021, Limetree Officials presented me and my husband, Rafael Rivera, with a Release of Certain Claims for property damage in the amount of \$5,002.00. I was advised by my Attorney not to sign the release.
- 9. Since then, we have not been able to clean the house or the cistern and continue to bathe and brush our teeth in the water.
- 10. We have had to buy our own water to cook and drink as Limetree will only allow two cases a week of water and it is not enough for our water needs.
