**ADDENDUM TO PROOF OF CLAIM**

This addendum is attached to and a part of the of the proof claim filed by **Excel Construction and Maintenance V.I., Inc.** (the “**Claimant**”) in the above-captioned chapter 11 case of **Limetree Bay Services, LLC** (the “**Debtor**”).

**1. Basis for Proof of Claim and Asserted Amount**

The Debtor as Owner and the Claimant as Contractor are parties to the following executory contracts (collectively, the “**Agreements**”)<sup>1</sup>:

- Term Services Agreement dated February 17, 2016 (the “**TSA**”)
- TSA dated June 18, 2018
- Agreement Addendum dates December 13, 2018
- Agreement Addendum to TSA dated July 19, 2019.
- Schedule B to TSA dated August 17, 2020.

Claimant asserts any and all Claims, as defined in section 101(5) of Title 11 of the United States Code (the “**Bankruptcy Code**”) arising under, related to, or in connection with the Agreements. The total amount owed by the debtor to the Claimant as of the petition date is **\$25,656,963.59** as set forth on the schedule attached to this addendum. Claimant asserts all rights provided by law under the lien it filed on June 24, 2021 with the Office of the Lieutenant Governor and Recorder of Deeds for the Virgin Islands, copy of which is attached. Claimant is currently unaware of the value of the secured portion of its claim, and reserves all of its rights thereto.

**2. Reservation of Rights for Administrative Priority Claim**

Claimant is willing to continue to perform work for the Debtor if requested subject to acceptable terms and conditions notwithstanding the filing of the Debtor’s petition. In such event, Claimant reserves its right to seek payment of the post-petition amounts owed as an administrative priority claim.

**3. Reservation of Other Rights and Claims**

If the Debtor seeks to affirm any of its contracts with Claimant, Claimant asserts the right to all cure amounts as provided and required by the Bankruptcy Code.

If the Debtor seeks to reject any of its contracts with Claimant, Claimant asserts the right to all damages caused by such rejection as provided and required by the Bankruptcy Code.

Claimant reserves any other claims for breach, damages, costs, expenses, or losses that Claimant has incurred or may incur based upon conduct of the Debtor, including any other non-compliance with or breach of its contracts with the Claimant.

<sup>1</sup> The agreements between the Debtor and Claimant were initially between the Debtor and Sun Constructors, Inc. (“**Sun**”). Sun amended its Articles and changed its name to Excel Construction and Maintenance V.I., Inc. effective August 17, 2018. The name change was recognized and acknowledged by the Debtor.

Claimant further asserts any and all claims for indemnity, contribution, reimbursement, recoupment, or subrogation under the Bankruptcy Code and applicable law arising under, related to, or in connection with the contracts.

The filing of this Proof of Claim is not and shall not be deemed or construed as: (i) a waiver or release of Claimant's rights against any other entity or person liable for all or any part of the Proof of Claim asserted herein; (ii) a consent by Claimant to the jurisdiction of this Court or any other court with respect to proceedings, if any, commenced in any case against or otherwise involving Claimant; (iii) a waiver or release of Claimant's right to mediate or arbitrate any dispute, as applicable, including the amount or nature of the Proof of Claim; (iv) a waiver or release of Claimant's right to trial by jury in this Court or any other court in any proceeding as to any and all matters so triable herein, whether the same be designated legal or private rights or in any case, controversy, or proceeding related hereto, notwithstanding the designation or not of such matters as "core proceedings" pursuant to 28 U.S.C. § 157(b)(2), and whether such jury trial is pursuant to statute or the United States Constitution; (v) a consent by Claimant's to a jury trial in this Court or any other court in any proceeding as to any and all matters so triable herein or in any case, controversy, or proceeding related hereto, pursuant to 28 U.S.C. § 157(e) or otherwise; (vi) a waiver or release of Claimant's right to have any and all final orders in any and all non-core matters or proceedings entered only after de novo review by a United States District Court Judge; (vii) a waiver of the right to move to withdraw the reference with respect to the subject matter of this proof of claim, any objection thereto, or other proceeding which may be commenced in this case against or otherwise involving Claimant; (viii) a waiver or release of Claimant's right to setoff under the Bankruptcy Code or recoupment; or (ix) a waiver of Claimant's right to assert any additional claims that may be entitled to administrative priority under sections 503 and 507 of the Bankruptcy Code.

This ADDENDUM is hereby made by and between Limetree Bay Refining, LLC, 1 Estate Hope, Christiansted, St. Croix, VI 00820 ("LIMETREE"), and Sun Constructors, Inc., 8641 United Plaza Boulevard, Baton Rouge, LA 70809 ("CONTRACTOR") and together with LIMETREE, the "Parties" and, individually, a "Party") to amend and revise the Term Services Agreement LTR-015 dated June 18, 2018 ("Agreement"); this amendment is effective December 3, 2018 ("Effective Date").

Whereas the Parties previously entered into the above referenced Agreement where under CONTRACTOR is performing certain Work for LIMETREE at LIMETREE's facility located at St. Croix, United States Virgin Islands; and now agree that certain revisions must be made to the Agreement to accommodate ongoing and future work; and the Parties wish to make such changes to receive the benefits of such work;

THEREFORE, for good, valuable and mutual consideration, the receipt and sufficiency of which are acknowledged, the Parties agree as follows:

1. Article 9 – **INDEMNITY AND LIMITATION ON LIABILITY** is replaced in its entirety as follows:

**9 INDEMNITY AND LIMITATION ON LIABILITY**

- 9.1 CONTRACTOR shall defend, indemnify, and hold harmless the Indemnified Parties from and against all Claims which any of the Indemnified Parties may be liable arising out of the performance or non-performance of the Work by CONTRACTOR, its employees, or subcontractors, or anyone acting under CONTRACTOR's direction or control, or anyone for whose acts CONTRACTOR may be liable. In all situations in which the foregoing indemnity obligation may potentially apply, CONTRACTOR shall defend the Indemnified Parties until and unless it is finally determined in a court proceeding or arbitration the parties' relative degree of fault. CONTRACTOR shall not be responsible to indemnify the Indemnified Parties for damages directly assessed against the Indemnified Parties for their own negligence or willful misconduct.

- 9.2 Limitation on Liability.

- (i) Limitation on Damages for Failure to Deliver Conforming Work. The total amount of damages that LIMETREE may recover from CONTRACTOR resulting from CONTRACTOR's failure to deliver Work in accordance with the terms of this Agreement and the applicable Work Release (including any warranty claims or claims for re-work) is limited to an amount equal to the Work Release price for the applicable Work.

- (ii) Limitation on Damages for Damage to LIMETREE's Property. The total amount of damages that LIMETREE may recover from CONTRACTOR for damage to LIMETREE property (whether real or personal), shall not exceed the limits of insurance required to be maintained by CONTRACTOR pursuant to this Agreement. For greater certainty, this limitation is based on the policy levels set forth herein and not on the actual amount of insurance proceeds collected by CONTRACTOR.

- (iii) Waiver of Consequential Damages. Except Claims for which there is an indemnification obligation hereunder and unless otherwise expressly set forth herein, each party's liability for damages under this Agreement is limited to direct, actual damages, whether such Claim is in tort, contract or otherwise, and neither party shall be liable to the

Claimant asserts any and all Claims, as defined in section 101(5) of Title 11 of the United States Code (the “**Bankruptcy Code**”) arising under, related to, or in connection with the Agreements. The total amount owed by the debtor to the Claimant as of the petition date is **\$25,656,963.59** as set forth on the schedule attached to this addendum. This ADDENDUM is hereby made by and between Limetree Bay Refining, LLC, 1 Estate Hope, Christiansted, St. Croix, VI 00820 ("LIMETREE"), and Sun Constructors, Inc., 8641 United Plaza Boulevard, Baton Rouge, LA 70809 ("CONTRACTOR") and together with LIMETREE, the "Parties" and, individually, a "Party") to amend and revise the Term Services Agreement LTR-015 dated June 18, 2018 ("Agreement"); this amendment is effective December 3, 2018 ("Effective Date").

Whereas the Parties previously entered into the above referenced Agreement where under CONTRACTOR is performing certain Work for LIMETREE at LIMETREE's facility located at St. Croix, United States Virgin Islands; and now agree that certain revisions must be made to the Agreement to accommodate ongoing and future work; and the Parties wish to make such changes to receive the benefits of such work;

THEREFORE, for good, valuable and mutual consideration, the receipt and sufficiency of which are acknowledged, the Parties agree as follows:

1. Article 9 – **INDEMNITY AND LIMITATION ON LIABILITY** is replaced in its entirety as follows:

#### **9 INDEMNITY AND LIMITATION ON LIABILITY**

- 9.1 CONTRACTOR shall defend, indemnify, and hold harmless the Indemnified Parties from and against all Claims which any of the Indemnified Parties may be liable arising out of the performance or non-performance of the Work by CONTRACTOR, its employees, or subcontractors, or anyone acting under CONTRACTOR's direction or control, or anyone for whose acts CONTRACTOR may be liable. In all situations in which the foregoing indemnity obligation may potentially apply, CONTRACTOR shall defend the Indemnified Parties until and unless it is finally determined in a court proceeding or arbitration the parties' relative degree of fault. CONTRACTOR shall not be responsible to indemnify the Indemnified Parties for damages directly assessed against the Indemnified Parties for their own negligence or willful misconduct.

#### **9.2 Limitation on Liability.**

(i) Limitation on Damages for Failure to Deliver Conforming Work. The total amount of damages that LIMETREE may recover from CONTRACTOR resulting from CONTRACTOR's failure to deliver Work in accordance with the terms of this Agreement and the applicable Work Release (including any warranty claims or claims for re-work) is limited to an amount equal to the Work Release price for the applicable Work.

(ii) Limitation on Damages for Damage to LIMETREE's Property. The total amount of damages that LIMETREE may recover from CONTRACTOR for damage to LIMETREE property (whether real or personal), shall not exceed the limits of insurance required to be maintained by CONTRACTOR pursuant to this Agreement. For greater certainty, this limitation is based on the policy levels set forth herein and not on the actual amount of insurance proceeds collected by CONTRACTOR.

(iii) Waiver of Consequential Damages. Except Claims for which there is an indemnification obligation hereunder and unless otherwise expressly set forth herein, each party's liability for damages under this Agreement is limited to direct, actual damages, whether such Claim is in tort, contract or otherwise, and neither party shall be liable to the
