**NOTICE OF OBJECTION TO CLAIM NO. 1
BY RUBIN & BETTY BARNES TTEES DTD 1/31/06**

TO: Rubin & Betty Barnes TTEES DTD 1/31/06 and the Service List

Madison Park Church of God, Inc., d/b/a Madison Park Church of God, as debtor and debtor-in-possession (the "Debtor"), has filed an objection to your claim (Claim No. 1) relating to your ownership of certain Subordinate General Mortgage Bonds, 2007 Series B. The Debtor argues that Claim No. 1 is duplicative of and superseded by Claim No. 7 filed by Timothy Landis, PC, trustee pursuant to that certain Trust Indenture dated July 31, 2007 by and among Reliance Trust Company, Timothy Landis, PC and the Debtor (the "Series B Trustee"), on behalf of and for the benefit of all bondholders holding Subordinate General Mortgage Bonds, 2007 Series B. A copy of the objection has been mailed to you at the address provided in your proof of claim.

As a result of the objection, your claim may be reduced, modified, or eliminated. You should read these papers carefully and discuss them with your attorney.

If you do not want the Court to eliminate or change your claim, then **on or before Wednesday, January 22, 2014** you or your attorney must:
