**NOTICE OF APPLICATION AND OPPORTUNITY TO OBJECT**

On January 24, 2014, Madison Park Church of God, Inc. d/b/a Madison Park Church of God, as reorganized debtors (the "Debtors"), and Taft Stettinius & Hollister LLP ("Taft") filed the *Second and Final Application of Taft Stettinius & Hollister LLP for Allowances of Fees and Reimbursement of Expenses* (the "Application"). In the Application, Taft seeks final approval of fees in the amount of \$248,791.50 and expenses in the amount of \$1,903.19 for the time period of the inception of the Chapter 11 case through and including December 31, 2013 (the "Application Period"). Of those amounts, \$199,033.20 in fees and \$1,903.19 in expenses have been paid to Taft on an interim basis pursuant to four notices of draw. By filing the Application, Taft seeks payment of \$49,758.30, which is the 20% holdback for the Application Period.

If you have not received a copy of the Application, you may get one by contacting: (a) the person who signed this notice; (b) at the clerk's office, or (c) contacting the Debtor's noticing agent BMC Group, Inc. at <http://bmcgroup.com> and selecting the Madison Park Church of God, Inc. case and checking on the Court Docket and selecting Docket No. 152.

If you do not want the court to grant the Application, then **on or before February 14, 2014**, you or your attorney must:

1. File a written objection to the Application, which should explain the reasons why you object, with the Clerk of the United States Bankruptcy Court at:

If you mail your objection, you must mail it early enough so that it will be received by the date it is due.

If you do not file an objection by the date it is due, the court may grant the relief requested in the Application without holding a hearing. If you do file an objection, the court will set the Application for hearing, which you or your attorney will be expected to attend.
