


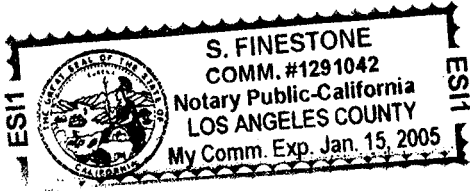

**NOTICE OF DEBTOR'S MOTIONS TO APPROVE
SETTLEMENT AGREEMENTS WITH CERTAIN INSURERS**

PLEASE TAKE NOTICE THAT Met-Coil Systems Corporation, debtor and debtor-in-possession in the above-captioned Chapter 11 Case (the "**Debtor**"), has filed with the Bankruptcy Court¹ motions to approve settlement agreements, and maintain such settlement agreements under seal, with (a) New Hampshire Insurance Company, National Union Fire Insurance Company of Pittsburgh, PA and/or other insurance companies affiliated with American International Group ("**AIG**"); and (b) Travelers' Casualty and Surety Company, The Travelers Indemnity Company, The Travelers Indemnity Company of Illinois n/k/a Travelers Property Casualty Company of America and Gulf Insurance Company ("**Travelers**").

PLEASE TAKE FURTHER NOTICE that the Debtor intends to file on or about July 8, 2004, motions to approve settlement agreements, and to maintain such settlement agreements under seal, with (a) OneBeacon Insurance Group, including but not limited to Potomac Insurance Company, now known as OneBeacon Insurance Company, and General Accident Insurance Company, now known as Pennsylvania General Insurance Company ("**OneBeacon**"); and (b) Pacific Employers Insurance Company and International Insurance Company ("**PEIC**"). The motions to approve the settlement agreements, and maintain such settlement agreements under seal, with AIG, Travelers, OneBeacon and PEIC shall be collectively referred to herein as the "**Settlement Motions**".

On June 22, 2004, the Debtor filed its Fourth Amended Disclosure Statement (the "**Disclosure Statement**"), which the Bankruptcy Court has approved as containing adequate information, and the Plan. The Plan contains the TCE Channeling Injunction for the benefit of, among others, AIG, Travelers, OneBeacon and PEIC. A description of the TCE Channeling Injunction is included in the solicitation materials accompanying this Notice of Debtor's Motions to Approve Settlement Agreements with Certain Insurers. The settlements under the Settlement Motions are in the aggregate amount of \$16,900,000. If such Settlement Motions are approved, such monies will be available for funding the Debtor's Plan, provided that the Bankruptcy Court approves the Plan containing the TCE Channeling Injunction.

The hearing with respect to each of the Settlement Motions will be held on July 28, 2004 at 11:30 a.m. (Eastern Time). The objection deadline with respect to the Settlement Motions is July 21, 2004 at 4:00 p.m. (Eastern Time).
