**NOTICE OF (A) EFFECTIVE DATE OF PLAN AND (B) DEADLINE TO FILE REQUESTS FOR PAYMENT OF ADMINISTRATIVE EXPENSE AGAINST MET-COIL SYSTEMS, LLC (f/k/a MET-COIL SYSTEMS CORPORATION)**

**TO ALL PERSONS AND ENTITIES WITH ADMINISTRATIVE EXPENSES AGAINST MET-COIL SYSTEMS, LLC (f/k/a MET-COIL SYSTEMS CORPORATION) (the "Reorganized Debtor"):**

**Effective Date.** On August 17, 2004, the United States Bankruptcy Court for the District of Delaware (the "Court") confirmed the Fourth Amended Chapter 11 Plan of Reorganization Proposed by Met-Coil Systems Corporation and Mestek, Inc., as Co-Proponents dated June 22, 2004 (as confirmed, the "Plan"). On October 19, 2004, the Effective Date of the Plan occurred.

**Administrative Bar Date.** Pursuant to an order of this Court (the "Administrative Bar Date Order"), and in accordance with Fed. R. Bankr. P. 3003(c), all persons and entities, including individuals, partnerships, estates and trusts (except those persons and entities that are excused pursuant to the terms of the Administrative Bar Date Order) who have a claim for an Administrative Expense other than an Excluded Administrative Expense (each as defined in the Administrative Bar Date Order) that accrued between August 26, 2003 and October 19, 2004 must file a request for payment on or before 4:00 p.m. (Pacific Time) on December 3, 2004 (the "Administrative Bar Date").

ANY PERSON OR ENTITY (EXCEPT A PERSON OR ENTITY WHO IS EXCUSED BY THE TERMS OF THE ADMINISTRATIVE BAR DATE ORDER) WHO FAILS TO FILE A REQUEST FOR PAYMENT ON OR BEFORE THE ADMINISTRATIVE BAR DATE SHALL BE FOREVER BARRED, ESTOPPED AND ENJOINED FROM ASSERTING SUCH CLAIM (OR FILING A REQUEST FOR PAYMENT WITH RESPECT TO SUCH CLAIM) AGAINST THE DEBTOR OR THE REORGANIZED DEBTOR; THE DEBTOR, THE REORGANIZED DEBTOR AND THEIR RESPECTIVE PROPERTY WILL BE FOREVER DISCHARGED FROM ANY AND ALL INDEBTEDNESS OR LIABILITY WITH RESPECT TO SUCH ADMINISTRATIVE EXPENSE; AND SUCH HOLDER SHALL NOT BE PERMITTED TO PARTICIPATE IN ANY DISTRIBUTION IN THIS CHAPTER 11 CASE ON ACCOUNT OF SUCH ADMINISTRATIVE EXPENSE, OR TO RECEIVE FURTHER NOTICES REGARDING SUCH EXPENSE.
