**NOTICE OF WITHDRAWAL OF OBJECTION TO CLAIM NOS. 174 AND 175
WITHOUT PREJUDICE TO RE-FILE OBJECTION [RE: D.I. 327]**

Met-Coil Systems Corporation (the "**Debtor**"), debtor and debtor in possession in the above-captioned Chapter 11 case, for its Notice of Withdrawal of Objection to Claim Nos. 174 and 175 Without Prejudice to Re-File Objection, states as follows:

1. On November 11, 2003, Theresa Mejdrech, Daniel Mejdrech, Mary Beno, Mark Beno et al. (collectively, the "Mejdrech Class") and Anne Schreiber ("Schreiber") separately filed proofs of claim against the Debtor, each in an unliquidated amount. The claims are numbered 174 and 175, respectively.

2. On December 5, 2003, the Debtor filed its Second Omnibus Objection (Substantive) to Certain Claims Pursuant to Section 502 of the Bankruptcy Code, Rule 3007 of the Federal Rules of Bankruptcy Procedure and Rule 3007-1 of the Local Rules of Bankruptcy Procedure (D.I. 327) (the "Second Objection").

3. The Debtor hereby withdraws its objections to Claim Nos. 174 and 175 of the Mejdrech Class and Schreiber, respectively, as set forth in the Second Objection, without prejudice to the Debtor's right to re-file such objections or to assert any other objections, whether substantive or non-substantive.
