TO: The United States Trustee for the District of Delaware, Counsel to the Debtors and all parties requesting notice under Bankruptcy Rule 2002



**THIRD APPLICATION OF ERIC D. GREEN
FOR INTERIM ALLOWANCE OF
COMPENSATION AND REIMBURSEMENT OF EXPENSES**

Pursuant to 11 U.S.C. §§ 330 and 331 and Rule 2016 of the Federal Rules of Bankruptcy Procedure, Eric D. Green (hereinafter "Eric D. Green") hereby moves this Court for reasonable compensation for professional legal services as Legal Representative of Future Claimants (the "Future Claimants' Representative") in the amount of \$5,100.00 together with reimbursement for actual and necessary expenses incurred in the amount of \$186.77 for the period commencing December 1, 2003 through and including December 31, 2003 (the "Fee Period"). In support of its Application, Eric D. Green respectfully represents as follows:

1. Eric D. Green was appointed as the Future Claimants' Representative in connection with this chapter 11 case, pursuant to an Order dated October 20, 2003, nunc pro tunc to September 10, 2003. The Order authorized Eric D. Green to be compensated on an hourly basis and to be reimbursed for actual and necessary out-of-pocket expenses.

COMPENSATION PAID AND ITS SOURCE

2. All services for which compensation is requested by Eric D. Green were performed for or on behalf of Future Claimants and not on behalf of any debtor, creditor or other person.

3. During the period covered by this Application, Eric D. Green has received no payment and no promises for payment from any source for services rendered or to be rendered in

any capacity whatsoever in connection with these cases. There is no agreement or understanding between Eric D. Green and any other person, other than members of the firm, for the sharing of compensation to be received for services rendered in these cases.

4. Attached hereto as Exhibit A is a detailed statement of fees incurred during the period December 1, 2003 through December 31, 2003 showing the amount of \$5,100.00 due for fees.

SUMMARY OF SERVICES RENDERED

5. Eric D. Green has rendered professional services in this case during the Fee Period.

6. The services rendered by Eric D. Green during the Fee Period are detailed set forth in Exhibit A. Eric D. Green has rendered services with detail, along with the number of hours for each service performed and the total compensation sought in the attachments hereto.

DISBURSEMENTS

7. Eric D. Green has incurred out-of-pocket disbursements during the Fee Period in the amount of \$186.77. This disbursement sum is broken down into categories of charges, including, among other things, travel expenses and expenses for working meals. A complete review by category of the expenses incurred for the Fee Period November can be found in the attachments hereto as Exhibit A.

VALUATION OF SERVICES

9. Eric D. Green has expended a total of 10.20 hours in connection with this matter during the Fee Period.

10. The amount of time spent by Eric D. Green providing services to the Future Claimants for the Fee Period is fully set forth in Exhibit A attached hereto. These are Eric D. Green's normal hourly rates of compensation for work of this character. The reasonable value of the


services rendered by Eric D. Green for the Fee Period as Future Claimants' Representative in these cases is \$5,100.00.

11. Eric D. Green believes that the time entries included in Exhibit A attached hereto are in compliance with the requirements of Local Rule 2016-2.

12. In accordance with the factors enumerated in 11 U.S.C. § 330, the amount requested is fair and reasonable given (a) the complexity of this case, (b) the time expended, (c) the nature and extent of the services rendered, (d) the value of such services, and (e) the costs of comparable services other than in a case under this title.

WHEREFORE, Eric D. Green requests that allowance be made to it in the sum of \$5,100.00 compensation for necessary professional services rendered to the Committee for the Fee Period, and the sum of \$186.77 for reimbursement of actual necessary costs and expenses incurred during the Fee Period, and further requests such other and further relief as this Court may deem just and proper.
