I hereby represent that neither I, nor any member of or professional employed by the Professional has agreed to share or will share any portion of the compensation to be received from the Debtor with any other person other than the members and regular employees of the Professional, other than as permitted pursuant to § 504(b)(1) of the Bankruptcy Code.
