**ORDER SHORTENING AND LIMITING NOTICE WITH RESPECT TO
BAKER & MCKENZIE'S MOTION TO APPROVE ADMINISTRATIVE CLAIM**

Upon consideration of Baker & McKenzie's Motion to Shorten Notice Period With Respect to its Motion for Payment of Administrative Claim (the "Motion to Shorten"); the Court having considered the Motion to Shorten; the Court having jurisdiction over this matter; venue being appropriate; and notice of the Motion to Shorten having been found proper under the circumstances; and just cause for the relief requested in the Motion to Shorten being present;

IT IS HEREBY ORDERED THAT:

1. The Motion to Shorten is granted.

Walrath, Chief United States Bankruptcy Judge, in the United States Bankruptcy Court of the District of Delaware, 824 Market Street, Wilmington, Delaware, 19801.
3. Objections to the Motion, if any, must be filed with the Clerk of Court, United States Bankruptcy Court of the District of Delaware, 5th Floor, 824 Market Street, Wilmington, Delaware 19801, on or before June 18, 2004 at 4:00 p.m. EST.
4. At the same time, a copy of the objection must also be served on: (i) counsel for the Debtor, Goldberg Kohn Bell Black Rosenbloom & Moritz, Ltd., 55 East Monroe Street, Suite 3700, Chicago, Illinois 60603 (Attn: Ronald Barliant, Esq.), and Morris, Nichols, Arsht &

Tunnell, 1201 N. Market Street, Wilmington, Delaware 19899 (Attn : Eric D. Schwartz, Esq.) and (ii) counsel for Baker & McKenzie, Potter Anderson & Corroon LLP, 1313 North Market Street, Hercules Plaza, Wilmington, DE 19801 (Attn: Rosalie Spelman).

5. Notice of the Motion upon the following parties was sufficient and appropriate under the circumstances, and thus is approved: (a) the United States Trustee, (b) counsel to the Committee, (c) counsel to the Debtor's secured lender, (d) counsel to Mestek; (e) counsel for the future claimants' representative; and (f) all those that have requested notice of pleadings pursuant to Bankruptcy Rule 2002.
