**STIPULATION ALLOWING CLAIM OF CERTAIN PERSONAL INJURY
CLAIMANTS AND THE DEVANE CLAIMANTS SOLELY
FOR THE PURPOSE OF VOTING ON DEBTOR'S SECOND AMENDED CHAPTER 11
PLAN OF REORGANIZATION PROPOSED BY MET-COIL SYSTEMS
CORPORATION AND MESTEK, INC., AS CO-PROONENTS**

Met-Coil Systems Corporation, debtor and debtor in possession in the above-captioned Chapter 11 case (the "**Debtor**"), Mestek, Inc. ("**Mestek**"), the PI Claimants¹ and the DeVane Claimants² hereby agree and stipulate as follows:

WHEREAS, on August 26, 2003, the Debtor filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code;

WHEREAS, the PI Claimants each filed a proof of claim (Claim Nos. 195, 196, 197, 198, 199 and 200) in an unliquidated general unsecured amount against the Debtor (collectively, the "**PI Claims**");

WHEREAS, the DeVane Claimants each filed a proof of claim (Claims 188, 189, 190, 191, 192 and 193) in an unliquidated general unsecured amount against the Debtor (collectively, the "**Devane Claims**");

WHEREAS, on June 18, 2004, the Debtor and Mestek filed a Third Amended Chapter 11 Plan of Reorganization Proposed by Met-Coil Systems Corporation and Mestek, Inc., as Co-Proponents (as may be amended, modified or supplemented from time to time, the "**Plan**");³

WHEREAS, the Debtor, Mestek, the PI Claimants and the DeVane Claimants wish to enter into an agreement pursuant to Rule 3018(a) of the Federal Rules of Bankruptcy Procedure solely for the purpose of allowing the Claimants to vote on the Plan.

NOW, THEREFORE, the Debtor, Mestek, the PI Claimants and the DeVane Claimants agree as follows:

1. The following PI Claimants shall be deemed to hold a Class 6 Claim (TCE PI Claims) against the Debtor's estate in the following amounts solely for purposes of voting on the Plan: (i) Laura Wroble (Claim 195) - \$75,000.00; (ii) Denise Ann Ehrhart (Claim 196) - \$200,000; (iii) Virginia Hallmer (Claim 197) - \$60,000.00; and (iv) Daniel Pelzer (Claim 199) - \$210,000.00. Laura Wroble, Denise Ann Ehrhart, Virginia Hallmer and Daniel Pelzer shall be authorized and allowed to cast one ballot each in the respective amounts set forth above.

2. The following PI Claimants shall be deemed to hold a Class 4.3 Claim (General Unsecured Claims other than Convenience Claims, Mestek Unsecured Claim (if Mestek is the Winning Plan Sponsor), TCE Property Damage Claims arising in connection with the Mejdrech Litigation and TCE PI Claims) against the Debtor's estate in the following amounts solely for purposes of voting on the Plan: (i) Sally Pepping (Claim 200) - \$75,000; and (ii) Deborah Meyer, as Executrix of the Estate of Nicholas Meyer, Deceased and Individually and as Mother and Next Friend of Derek Meyer, a Minor, and Danielle Meyer, a Minor (Claim 198) - \$400,000.

Sally Pepping and Deborah Meyer shall be authorized and allowed to cast one ballot in the respective amounts set forth above.


3. The Devane Claimants shall be deemed to hold a Class 4.3 Claim (General Unsecured Claims other than Convenience Claims, Mestek Unsecured Claim (if Mestek is the Winning Plan Sponsor), TCE Property Damage Claims arising in connection with the Mejdrech Litigation and TCE PI Claims) against the Debtor's estate in the following amounts solely for purposes of voting on the Plan: (i) Jeanette Devane/Lee Herrera - \$36,000; (ii) Thomas and Barbara Frantik - \$125,000; (iii) Richard and Jane Kuta - \$145,000; (iv) Michael Papadopolous - \$15,000; (v) Andrew Wroble - \$42,500; and (vi) Karen Mulacek - \$5,000. Each of the Devane Claimants shall be authorized and allowed to cast one ballot each in the respective amounts set forth above.

4. This Stipulation is being executed for the sole purpose of allowing the Claimants to vote on the Plan. Nothing herein shall be deemed a determination of any of Claims 188, 189, 190, 191, 192, 193, 195, 196, 197, 198, 199 and 200 against the Debtor's estate or Mestek for any other purpose, including, without limitation, with respect to each of the PI Claimants' and each of the DeVane Claimants' respective entitlement to distributions under any plan, or an admission, release or waiver with respect to its claims against the Debtor or Mestek, including, without limitation, as to the amount, extent, validity or priority of any such claim. The parties reserve any and all rights in connection with the ultimate allowance or disallowance of Claims 188, 189, 190, 191, 192, 193, 195, 196, 197, 198, 199 and 200.

5. This Stipulation may be executed in counterparts, each of which shall be deemed an original, but together shall constitute one in the same instrument.




