ORDERED THAT, each of the Claim identified in Exhibit 2 attached hereto and incorporated herein by reference are hereby disallowed and expunged, in whole or in part, as indicated in Exhibit 2; and it is further

ORDERED THAT, each of the Claims identified in <u>Exhibit 3</u> attached hereto and incorporated herein by reference are reduced, liquidated or otherwise adjusted and reclassified, in whole or in part, to their proper classification as set forth in the column entitled "Reclassification Amount\*/Claim Class\*\*" on <u>Exhibit 3</u>; and it is further

ORDERED THAT, each of the Claims identified in <u>Exhibit 4</u> attached hereto and incorporated herein by reference are reclassified in whole or in part, to their proper classification as set forth in the column entitled "Reclassification Amount\*/Claim Class\*\* on <u>Exhibit 4</u> and disallowed and expunged as indicated on <u>Exhibit 4</u>; and it is further

ORDERED THAT, each of the Claims identified in <u>Exhibit 5</u> attached hereto and incorporated herein by reference are hereby disallowed and expunged, in whole or in part, as indicated in <u>Exhibit 5</u>; and it is further

ORDERED THAT, each of the Claims and the objections by the Trust thereto constitutes a separate contested matter as contemplated by Fed. R. Bankr. P. 9014; and it is further

ORDERED THAT, pursuant to Rule 54(b) of the Federal Rules of Civil Procedure, made applicable in contested matters by Rules 7054 and 9014 of the Federal Rules of Bankruptcy Procedure, the Court hereby directs entry of a final judgment with respect to the Objection that is
