1. On August 30, 2013, the Oldco M Distribution Trust (the “Trust”) filed the Omnibus Objection of Oldco M Distribution Trust Seeking to Disallow, Reduce, Reclassify, and

Expunge Certain Claims (Omnibus Objection No. 34) (Docket No. 2355) (the “34th Omnibus Objection”). By the Objection, the Trust sought to disallow, among others, claim no. 3565 filed by Thornapple Township (“Claim No. 3565”) as set forth on Exhibit A attached thereto.

2. Based upon discussions between the Trust and Thornapple Township to resolve the Objection, on March 19, 2014, Thornapple Township filed claim no. 3733 (the “Amended Claim”), which amended and superseded Claim No. 3565.

3. By this Notice, and based upon the Amended Claim, the Trust is hereby withdrawing the Objection without prejudice only as to Claim 3565 as set forth on Exhibit 1 attached hereto and incorporated herein by reference.
