

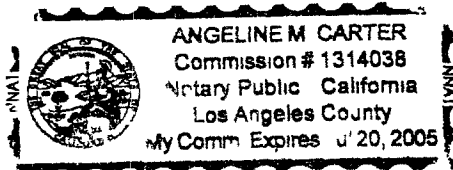



**MOTION PURSUANT TO § 365(d)(4) TO EXTEND TIME TO ASSUME  
OR REJECT LEASES OF NON-RESIDENTIAL REAL PROPERTY**

COME NOW Mississippi Chemical Corporation, *et al*, Debtors and debtors-in-possession in these jointly administered reorganization proceedings (“Debtors”), and move the Court to enter *interim* and final Orders allowing them ninety (90) additional days to assume or reject unexpired leases of non-residential real property, and in support of this motion would respectfully show as follows

1 This Court has jurisdiction over this contested matter pursuant to 28 U S C §§ 157 and 1334. This matter is a core proceeding under 28 U S C § 157(b)(2)(A) and (O), and this motion is made pursuant to § 365 of the Bankruptcy Code 11 U S C §§ 101, *et seq* and Fed R Bankr P 9014.

2 Debtors filed with this Court their voluntary petitions for relief under Chapter 11 of the Bankruptcy Code on May 15, 2003, (the “Petition Date”) and are operating as debtors-in-possession pursuant to §§ 1107 and 1108 thereof. No trustee has been appointed as of the filing of this motion. An Official Committee of Unsecured Creditors has been appointed.

3       The Debtors are the lessees under certain unexpired leases of non-residential real property located in various states (the "Leases"), and the Leases are identified on collective Exhibit "A" attached hereto and incorporated herein by reference

4       The Leases are assets of significant importance to the Debtors, their estates and other affiliated entities of the Debtors, and the Debtors fully anticipate that they will assume all or a portion of these Leases

5       The Debtors request that the Court grant them until and including October 13, 2003 (a ninety (90) day extension from the current deadline of July 14, 2003) within which to assume or reject the Leases in order to preserve their rights to make these elections under § 365 and to allow them ample time to make a fully informed decision with respect thereto

6       Good cause exists for granting the Debtors the requested extension, and the extension will not cause any undue prejudice or harm to the lessor or any other interested party in this reorganization proceeding



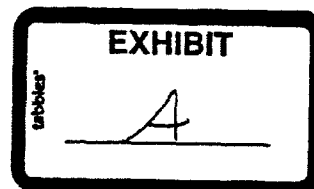
