**ORDER GRANTING MOTION FOR REJECTION
OF UNEXPIRED REAL PROPERTY LEASE IN FRISCO, TEXAS**

This matter coming on to be heard on Debtor Mosaic Prepaid Solutions Inc.'s Motion for Order Authorizing Rejection of Unexpired Nonresidential Real Property Lease in Frisco, Texas (the "Motion"); the Court having reviewed the Motion and papers submitted in support thereof and having heard the statements of counsel in support of the relief requested therein at a hearing thereon (the "Hearing"); the Court finding that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); the Court finding that notice of the Motion and the Hearing given by the Debtors was sufficient under the circumstances and that no further notice need be given except as herein provided; and the Court being fully advised in the premises and having determined that the legal and factual bases set forth in the Motion and at the Hearing on the Motion establish just cause for the relief herein granted;

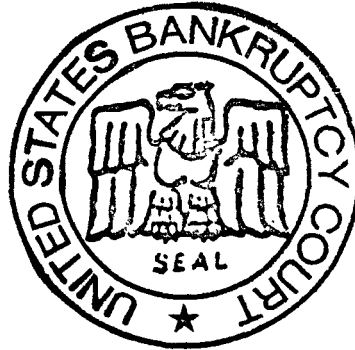
ORDERED that the unexpired Frisco Lease (as defined in the Motion) of non-residential real property is deemed rejected and the Debtors shall surrender the Addison Building (as defined in the Motion) by March 31, 2003; and

IT IS FURTHER ORDERED that, the Frisco Landlord (as defined in the Motion) shall have until sixty (60) days form the entry of this Order to file a proof of claim based upon the rejection of the Leases.
