## **DECLARATION OF KENNETH R. COOKSON**

- I, Kenneth R. Cookson, declare as follows:
- 1. I am of lawful age and, if called upon, I could and would testify competently to the matters set forth herein. I am a Director of Kegler, Brown, Hill & Ritter Co., LPA. ("Kegler Brown") responsible for Kegler Brown's representation of the Debtor (the "Debtor").
- 2. I am authorized to file this Declaration in support of the *Final Fee Application of Kegler Brown for Allowance and Payment of Compensation and Reimbursement of Expenses for the Period August 1, 2005 Through October 31, 2005* (the "Final Application").
